## **Online Databases**

The following databases may be found through the library web page.

### **BadgerLink**

This database provides access to magazines, newspapers and a statewide library catalog (WISCAT). It contains EBSCOhost, +20 databases identifying and indexing magazine articles. Its address is: <http://www.badgerlink.net>. It can also be found on the library web page at the Find Books & AV link.

### **Career and Technical Education**

Provides access to more periodicals than any other vo-tech database. Subjects include automobile, electronic, and computer technology; the building trades; graphic arts; medicine; nursing and pharmacy; child care; food service; etc. It has full text for more than 400 titles, including: *Law Office Management and Administrative Report*; *Office World News*; and *OfficePro* and *Office Solutions*.

### **LexisNexis Academic**

This database has a section called Legal Research which includes secondary literature (legal news, and law reviews) as well as case law, codes & regulations, international legal materials, and patent research.

### **SIRS Government Reporter**

Delivers thousands of full-text documents and graphics concerning a wide variety of topics: health, science, economics, environment, politics, foreign affairs, workplace issues, business and industry. The almanac databases are valuable tools for researching current and historic government documents; landmark and recent U.S. Supreme Court decisions; information about federal departments, agencies, elected leaders and more.

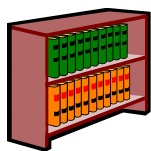
